

Genetic Molecular Testing Medicare Crosswalk

Purpose

The purpose of this crosswalk is to facilitate a reference document of CMS coverage guidance for Genetic Molecular Testing (GMT) services that may require prior authorization per OncoHealth for CY 2024. This crosswalk does not substitute the provider's responsibility to review the health plan's prior authorization requirements and policies. Additionally, the provider must consider any other relevant or updated versions of the listed items from the CMS website.

Crosswalk to CMS coverage guidance:

The following table contains coverage documents for various genetic molecular tests related to oncology. This is not an all-inclusive list and providers are required to reference the CMS website for any updates or changes. This document contains coverage documentation applicable to Puerto Rico, as of January 2024.
